- The Task Force began mapping mandatory (must have) and wants (nice to have) criteria for potential solutions for the task of removing all 10 portables from Hadley Junior High.

### **Proceedings:**

7:00 - 7:05 p.m. — **Welcome and Any Outstanding Matters**, Lori Taylor and Tom Voltaggio (co-chairs) offered a review of the meeting's agenda and the Task Force quickly moved forward to work on decision statements since there were no outstanding matters to address.

7:05 - 7:45 p.m. — **Decision Statements**, the Task Force engaged in discussion to clarify the decision statements that will encompass the work of the Task Force to begin determining criteria for developing solutions:

 Decision Statement: To create a long-term solution that will eliminate the portables at Hadley, provide space for full-day kindergarten (if implemented), and address deficiencies (work to "right-size" spaces) at each of the district schools.

7:45 - 8:58 p.m. — **Begin Criteria Work**, the Task Force discussed mandatory (must have) criteria necessary to begin to develop and vet potential solutions, as well as wants (nice to have) criteria to further govern decision making on proposed solutions:

- Proposed criteria examples included open-access for all students for services, ADA compliant, state and federal regulations, OSHA, adequate space for student populations, adequate space for faculty populations, flexible space for programming, timeframe variables/solution longevity, first cost considerations, operating cost consideration, community impact factors (environmental, financial, infrastructural, and so on), etc.
- The Task Force began discussion on criteria for the decision statement:
   "What are the facilities options available to eliminate all 10 portables at Hadley?"
  - The Task Force established mandatory (must have) criteria for a solution that would remove the portables from Hadley.
  - The Task Force established wants (nice to have) criteria for a solution that would remove the portables from Hadley.
