#### BOARD OF EDUCATION SPECIAL MEETING AUUGUST 20, 2015

#### Call to Order

Board President Erica Nelson called the August 20, 2015 Special Board of Education Meeting to order at 6:30 p.m.

#### Roll Call

Upon the roll being called, the following members answering present: Kurt Buchholz, Stephanie Clark, Patrick Escalante, Drew Ellis, Dean Elger, Joe Bochenski and Erica Nelson.

#### **Public Participation**

Resident Jeff Cooper noted that he made comments at the public hearing and was in disagreement on the response of the Board president on the topic of the funding of the assistant principal positions. Mr. Cooper also commented on the Board's practice of holding self-evaluation meetings in closed session, his perspective on the first Facility Task Force meeting and his concern about the FOIA from the Chicago Tribune noted on the August 10, 2015 FOIA report.

#### Adjourn to Closed Session

At 6:36 Board members Elger moved and Escalante seconded to adjourn to closed session to discuss self-evaluation, practices and procedures, or professional ethics, when meeting with a representative of a statewide association of which the District is a member and the appointment, employment, compensation, discipline, performance, or dismissal of specific employees of the District or legal counsel for the District, including hearing testimony on a complaint lodged against an employee or against legal counsel for the District to determine its validity. On a roll call vote answering "Aye": Bochenski, Elger, Escalante, Ellis, and Nelson answering "Nay": Clark, Buchholz

#### **Action Items**

Board member Bochenski moved and Elger seconded to approve the personnel report which includes employment recommendations and resignations as presented. Mr. Escalante noted that he planned to abstain from voting due to his family relationship to one of the recommended candidates. Board members asked clarifying questions on the nature of the recommendations prior to voting. On a roll call vote answering "Aye": Ellis, Elger, Bochenski and Nelson answering "Nay": Buchholz and Clark; Pass: Escalante. Motion passed.
